Overall objective	To increase effectiveness and efficiency of border management in Central Asia by introducing advanced elements of Integrated Border Management (IBM), assisting governments in developing and reforming their migration governance, mobility and trade facilitation policies and strengthening capacities of Border and Migration Agencies, thus contributing to security and economy developments at the national and regional levels.

## COMPONENT 1 - Institutional Development of Border Management Agencies (Component leader – Riga Technical University, Latvia)

- Resumed functioning of the Regional Platform of CA Border Guards and Customs Training Centres with which the countries can sustain
  durable educational cooperation and advance their training processes with modern educational approaches. Building upon the training needs
  and best practices, exchanges of trainers and trainees were organised among CA Training Institutions.
- Promoted the introduction of IBM elements into the curriculum of CA Border Guards and Customs higher education and training institutions, and standardisation of study programmes with the professional frameworks of FRONTEX, EC DG TAXUD, and WCO PICARD. Assisted higher education institutions of Kazakhstan and Uzbekistan to prepare Customs specialists with evaluations to improve study programmes against the WCO criteria. The Al-Farabi Kazakh National University became the first university in CA to receive the WCO Certificate of Recognition, attesting that its academic programme complies with international standards for the Customs profession.
- Launched the **Distance Learning system** for BG training institutions **in Kyrgyzstan** (Osh & Bishkek) and operationalised the Distance Learning system for the CU higher military institute **in Uzbekistan**, enabling the application of modern technologies to educational processes (e-lectures and webinar sessions) and networking with the national and EU MS counterpart institutions.
- Enhanced the **administrative management pillar** of border management agencies through training and on-the-job practice in human resource management, financial planning and control, in compliance with international standards and EU best practices.
- Assisted with the mid-term review and further upgrade of the National IBM Strategies and their Action Plans for the period of 2012-2022 in Kyrgyzstan and the period of 2010-2025 in Tajikistan, generating recommendations for the priority areas of the IBM Action Plans in each country. Additionally, a situational analysis report of the training system in Border Agencies of Tajikistan was elaborated that provides a baseline of current capacity and gaps, along with key recommendations, contributing to the implementation of Section 16 of the National IBM Strategy / Action Plan.
- Assisted CA border management agencies in strengthening the principles of law-enforcement ethics and professional standards through targeted training covering work relations/environment, intra-service and inter-agency cooperation and anti-corruption measures. Assisted Kyrgyzstan with the updates of the Action Plans on the eradication of systemic corruption in three border management agencies (State Border Service, State Customs Service and State Inspection on Veterinary & Phytosanitary Security), that were further endorsed by the Government and transferred for implementation.
- Supported CA state officials in attending high-level dialogues in the framework of the Central Asia Border Security Initiative (CABSI),
  Conference of Regional Cooperation on Border Security in CA (Issyk-Kul Initiative) International Border Police Conference (IBPC) and Almaty/
  Budapest/ Prague Processes, as well as study visits to EU MS professional agencies.

# COMPONENT 2 - Institutional Framework for Management of Mixed Migration Flows at Borders (Component leader – State Border Guard of Latvia)

- Assisted CA Border Guard Agencies in establishing/strengthening identification and profiling mechanisms and developing the Methodology for the identification of Foreign Terrorist Fighters at BCPs.
- Developed recommendations for legal and instrumental procedures governing inter-agency and intra-service cooperation and information
   exchange, as well as strengthened the capacity of management, frontline and patrolling staff on the issues of border checks, document


security, "green" border surveillance techniques, investigative procedures, public service standards, responses to emergency situations, service dog training, reporting and referral mechanisms and policies on the return of irregular migrants, readmission arrangements, voluntary return and reintegration practices, border delimitation and demarcation procedures.


- An assessment was undertaken of the existing legal acts of the Kyrgyz Republic in the field of migration management and combating
  irregular migration for further improvement of the legislative framework.
- Strengthened the technical base of Border Management Agencies through the **provision of specialised equipment to the BCPs and modern technologies to the training entities** of CA countries. Additionally, in response to the COVID-19 pandemic, the border management agencies were provided with **personal protective equipment** that were destined for frontline border officers.


## COMPONENT 3 - Adoption of trade facilitation regimes at borders (Component leader - Customs Department, Lithuania)


- Assisted CA Customs services in developing their risk management systems and investigation capacities, as well as developing new
  working tools for the detection of smuggled goods and fraud, enhanced knowledge and skills in intellectual analysis, Customs cyber
  intelligence, combatting criminal intelligence and encouraging the integration of risk management into the process of Customs controls.
- Assisted CA Phyto-Sanitary-Veterinary services in developing risk analysis for imported animals, food and plants as well as working
  procedures for risk assessment.
- Helped CA Customs services with advancing their policies towards the electronic E-Customs environment for import, export and transit
  operations by elaborating tailor-made IT strategies and roadmap guidelines for converting paper-based procedures into a paperless Customs
  environment.
- Assisted with the improvement of the practical skills of Customs and Law Enforcement units in the prevention and detection of illegal trafficking of goods and means of transport at the road and maritime BCPs, control of dual-use goods, protection of endangered species of animals and plants (CITES) and the protection of intellectual property rights (IPR).
- Helped CA Customs services to improve and align the national legislation with the provisions of WTO Trade Facilitation Agreement and Revised Kyoto Convention by providing legal expertise and training on the measures to be implemented for the accession to and/or implementing the international treaties and conventions. In Kyrgyzstan, an additional targeted analysis of the regulatory framework was carried out and recommendations were made to improve the procedure for the exchange of information between the customs authorities, as well as on issues of cross-border cooperation and interagency coordination.
- Contributed to promoting the awareness of the **EU Generalized Scheme of Preferences (GSP+) for Kyrgyzstan** and strengthening knowledge of the state agencies on GSP+ provisions/ requirements, and making preparations for the introduction of the Registered Exporter System (REX), which came into force in January 2019.
- Supported the State Customs Committee in the revision of the Customs Code of the Republic of Uzbekistan for the simplification of Customs procedures as per the norms of international conventions and agreements.

Within the framework of support to border management agencies of Central Asia in <u>undertaking prevention measures against the COVID-19 outbreak</u>, in the period April - August 2020, BOMCA Programme delivered protective medical equipment to the beneficiary agencies performing their duties directly on the border playing a frontline role in COVID-19 cross-border penetration for total value of 58,000 EUR as well as conducted 3 thematic webinars for Central Asian border agencies to raise awareness of practical border management solutions in responding to the COVID-19 crisis.
